COLLABORATIVE ACTIVITY RATIONALE

The importance of Stakeholder Involvement

Communication amongst researchers, practitioners, and other stakeholders to exchange knowledge, experiences, and issues is essential to restoration (Buisson et al. 2018). Actively communicating a project to those outside of research can increase trust in the project, improve relationships, and generate new networks (Durham et al., 2014). According to the second edition of the International Principles and Standards for the Practice of Ecological Restoration (SER principles), different stakeholders can take an active role in restoration (Gann et al., 2019).

A Mediterranean Gap

Within the Mediterranean, there are no recorded *Cystoseira* restorative actions that involve varied stakeholders. Although partnerships between academics and other sectors are valuable to restoration, these interactions are generally lacking in macroalgal reforestation (Eger et al., 2022). In the absence of stakeholder involvement, restoration outcomes can fall short (Gornish et al., 2021). The AFRIMED Business Club intends to start filling this gap.

Activity Execution

Participants will be introduced to a marine forest restoration conceptual frame, identifying key steps to implement a *Cystoseira s.l.* reforestation project. After a short presentation, a collaborative activity will be proposed facilitated through the online application "Klaxoon."

Participants will be encouraged to examine sections of the conceptual frame, which contributes to the AFRIMED best practice, and individually give feedback and ideas on how every different stakeholder can contribute to *Cystoseira s.l.* restoration.

A common discussion and brainstorming will allow the co-development of a conceptual frame that will be included in the AFRIMED Business Club final report.
